**Narrative****INITIAL INFORMATION :**

On Tuesday, July 27, 2021, at approximately 1340 hours, I, Officer Burnett, was dispatched to the Longmont police department at 225 Kimbark Street to contact an individual in the lobby regarding psychological child abuse.

The Watauga County Sheriff's Office was contacted and they advised that if Kenneth has issues, he can contact their department.

None of alleged crimes occurred in the city of Longmont and the case is being closed.
